

PHARMACY AND POISONS ORDINANCE (Chapter 138)

DIRECTION MADE BY THE DISCIPLINARY COMMITTEE  
OF THE PHARMACY AND POISONS BOARD OF HONG KONG

It is hereby notified that a Disciplinary Committee appointed by the Pharmacy and Poisons Board of Hong Kong under section 15 of the Pharmacy and Poisons Ordinance (Chapter 138, Laws of Hong Kong) to inquire into the conduct of an authorized seller of poisons, namely Chi Man Pharmacy O/B Sun Wui Medicine Company Limited, at Shop 2–3 Fu Ho Building, 3–7 Kau Yuk Road, Yuen Long, New Territories, Hong Kong has conducted an inquiry on 13 February 2025 in accordance with section 16 of the Pharmacy and Poisons Ordinance.

The said Committee was satisfied after the inquiry that Chi Man Pharmacy O/B Sun Wui Medicine Company Limited had been guilty of misconduct in that at the material time, Chi Man Pharmacy O/B Sun Wui Medicine Company Limited and its employee, MA Ming-ho were convicted of the following offences under the Pharmacy and Poisons Ordinance, the Pharmacy and Poisons Regulations (Chapter 138A, Laws of Hong Kong) made under the Pharmacy and Poisons Ordinance and the Trade Descriptions Ordinance (Chapter 362, Laws of Hong Kong) on the date specified below at Fanling Magistrates' Courts for which the following orders were imposed:—

In addition, the said Committee was satisfied that Chi Man Pharmacy O/B Sun Wui Medicine Company Limited had failed to comply with sections 1.4a, 1.4b, 2e, 2f, 2k, 3.1a, 3.1b, 3.3a, 3.3b, 3.3d and 3.4j of the Code of Practice for Authorized Seller of Poisons (2021 version).

It is further notified that under section 16(2)(b) of the Pharmacy and Poisons Ordinance, the said Committee directed Chi Man Pharmacy O/B Sun Wui Medicine Company Limited be disqualified from being an authorized seller of poisons for a period of 4 days with effect from 28 March 2025. The said Committee added that its direction should be published in the Government of the Hong Kong Special Administrative Region Gazette with an account of the proceedings.
