

PHARMACY AND POISONS ORDINANCE (Chapter 138)

DIRECTION MADE BY THE DISCIPLINARY COMMITTEE OF
THE PHARMACY AND POISONS BOARD OF HONG KONG

It is hereby notified that a Disciplinary Committee appointed by the Pharmacy and Poisons Board of Hong Kong under section 15 of the Pharmacy and Poisons Ordinance (Chapter 138, Laws of Hong Kong) to inquire into the conduct of an authorized seller of poisons, namely Jordan Dispensary Limited, at G/F, 143 Shanghai Street, Jordan, Kowloon has conducted an inquiry on 27 November 2023 in accordance with section 16 of the Pharmacy and Poisons Ordinance.

The said Committee was satisfied after the inquiry that Jordan Dispensary Limited had been guilty of misconduct in that at the material time, Jordan Dispensary Limited and its director, LAM Kin-man were convicted of the following offences under the Pharmacy and Poisons Regulations (Chapter 138A, Laws of Hong Kong) made under the Pharmacy and Poisons Ordinance, the Pharmacy and Poisons Ordinance, the Dangerous Drugs Ordinance (Chapter 134, Laws of Hong Kong) and the Antibiotics Ordinance (Chapter 137, Laws of Hong Kong) on the dates specified below at Kwun Tong Magistrates' Courts for which the following orders were imposed:—

In addition, the said Committee was satisfied that Jordan Dispensary Limited had failed to comply with sections 1.4b, 2e and 2f of the Code of Practice for Authorized Seller of Poisons (2021 version), and sections 1.4a, 1.4b, 2e, 2f, 3.3a, 3.3b, 3.3d, 3.4b, 3.4f, 3.4g and 3.4j of the Code of Practice for Authorized Seller of Poisons (2015 version).

It is further notified that under section 16(2)(b) of the Pharmacy and Poisons Ordinance, the said Committee directed that Jordan Dispensary Limited be disqualified from being an authorized seller of poisons for a period of 35 days with effect from 9 January 2024. The said Committee added that its direction should be published in the Government of the Hong Kong Special Administrative Region Gazette with an account of the proceedings.
